SCHEDULE IV

(See Section 12)

Provisions with Regard to Disqualification of Members

1. Disqualification for Election or for Holding Office as a Member.—A per holding an office of profit under a Municipality, the Central Government the State Government shall be disqualified for election or for holding office member:

Provided that a person shall not be deemed to hold an office of prunder Municipality by reason, only that he is a Chairperson or Member of Municipality in the State.

- 2. Other Disqualifications of Candidates.—(1) A person who has been sentently a criminal Court,—
 - (a) to imprisonment for an offence under the Protection of Civil Rig Act, 1955 (Central Act 22 of 1955);
 - (b) for any offence other than an offence of political character, or offence not involving moral delinquency, such sentence not have been suspended, reversed or the offence pardoned, shall disqualified for election as a member, while undergoing the sentence and for five years from the date of expiration thereof.
- (2) A person shall be disqualified for election as a member, if such per is, on the date fixed for scrutiny of nomination for election,—
